



## GENERAL HALAL QUESTIONNAIRE

**PLEASE READ INFORMATION BELOW, BEFORE PROCEEDING TO COMPLETE THE FORM**

1. Pursuant to Clause 2.9 of Muis Halal Certification Conditions, this document is provided to Muis Halal certificate holder(s) ONLY, for the purpose of assessing the suitability of a low risk product to be used by Muis Halal applicants/certificate holders.
2. This document is NOT an alternative to Halal certificate and cannot be used for the purpose of application to Halal certification from Muis for the item declared in this document.
3. The General Halal Questionnaire (hereinafter "Questionnaire") shall be duly completed by the manufacturer of the product in the country of origin for the purpose of seeking approval from Majlis Ugama Islam Singapura (Muis), also known as the Islamic Religious Council of Singapore.
4. This Questionnaire shall be endorsed and signed by a management representative, preferably someone with a scientific background, from the manufacturing company.
5. This Questionnaire shall be completed and submitted to Muis, together with the **PRODUCT SPECIFICATION, PROCESS FLOW CHART** and any **OTHER INFORMATION** as required by Muis and / or Muis appointed agent. All information given to Muis will be processed with strict confidence.
6. All companies / establishments seeking approval from Majlis Ugama Islam Singapura (Muis) for the use of a Low and Medium-Low risk ingredients, may be given an approval for use in the Halal certified establishment, upon receiving the information requested in this document. Refer overleaf for the risk categorisation of the ingredients.
7. Muis may at its discretion request for more information as deemed necessary.
8. Muis reserves the right to approve use of an ingredient / product subject to the information provided in this Questionnaire and / or any other documents as required by Muis and / or Muis appointed agent.
9. Inaccurate and/or incomplete submissions will be rejected without further notice.
10. Any information provided, if found not to comply with the Syariah Law, Muis' Fatwa, Singapore Muis Halal Standards and/or Muis Halal Certification Conditions shall be rejected without further notice.
11. Any approval given is for a one-off basis only. Subsequent shipments shall be subject to another round of verification and documents submission by the Halal applicant / Halal certificate holder.

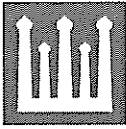

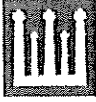


